**ADMISSION NOTICE 2010-11  
FOR DIRECT ADMISSIONS TO S.E. (2010-11)  
Admission procedure and rules of refund**

Candidates who have applied for Direct admissions to S.E. (2010-11) will be offered admission based on the seats available in branches such as (1)Chemical Engineering, (2)Electronics Engineering, (3)Production Engineering, (4)Biomedical Engineering, (5)Electronics & Telecommunication Engineering, (6)Information Technology & (7)Computer Engineering and as per schedule displayed on 5<sup>th</sup> August 2010. To accept the offer the candidate has to fulfill the following conditions:-

- (I) **Demand Draft of Rs.1,13,774/- (Rupees One lakh thirteen thousand seven hundred and seventy-four only)** in favour of “**The Principal, Dwarkadas J. Sanghvi College of Engineering, Mumbai**”. (The fees for the academic year 2010-11 has not yet been finalized. The difference in the fees finalized by Competent Authority will be payable immediately as and when finalized).

**Note:- A separate Notice for payment of fees will be put up on College Notice Board and Web-site for the candidates who have applied under Open Category and Gujarati Community (Linguistic Minority) but belonging to Reserve Category (SC/ST/VJNT/SBC/OBC).**

At the time of admission, Demand Draft should be submitted along with the following **original documents and one set of attested copies**:-

1. Statement of marks obtained at the qualifying examination (Diploma) for each attempt.
2. Equivalence Certificate issued by MSBTE is to be submitted by candidates passing Diploma from autonomous institution.
3. Provisional Passing Certificate
4. Institution Leaving Certificate
5. Statement of marks obtained at S.S.C. or its equivalent examination.
6. Proof regarding Minority status for GCLM candidates.
7. Affidavit of Minority status in case of Gujarati Minority candidates.
8. Domicile Certificate of Maharashtra State for Gujarati Community (Linguistic Minority) **of candidate.**
9. Provisional Eligibility Certificate from University of Mumbai.
10. Proof of Nationality
11. One stamp size photograph.

**II. If the branch offered at the time of admission is not accepted by the candidate, he/she will not eligible for the claim of admission in further rounds for that branch.**
